\*Effective March 1, 2009, an "assistance eligible" individual whose job ends between September 1, 2008 - December 31, 2009, as defined in the American Recovery and Reinvestment Act of 2009, will pay 35% of the otherwise applicable COBRA premium of that current plan year.

\*Premium assistance will be available to eligible individuals under the ARRA for up to 9 months.

\*If the "assistance eligible" individual's COBRA continuation coverage lasts for more than 9 months, the "assistance eligible" individual will have to pay the total amount of the premium to continue COBRA continuation coverage for the remainder of the coverage period.
