A. Review and Discuss 2022/23 Budget -

Lisa Stanton, Chief Financial Officer and Vice President of Operations and Finance, noted that a document detailing the responses to committee questions and information requests was sent out to the District Budget Committee prior to the start of this meeting (see file).

Ms. Stanton then reviewed a PowerPoint presentation consisting of descriptions and details regarding the following funds (see file):

- <u>General Fund</u>- accounts for the general operations of the College, including all financial resources and expenditures of the College, except for those required to be accounted for in another fund.
 - o General Fund- \$51.6 million
- <u>Capital Improvement Fund</u>- accounts for the receipt and disbursement of resources for buildings and land.
 - Capital Projects Fund \$14.2 million
 - \$2.3 million remaining from 2016 Bond Levy
 - \$2.8 million from sale of buildings
 - \$718,000 for completion of RWC Science Center
 - Potential proceeds from sale of buildings
- <u>Debt Service Fund</u>- accounts for the accumulation of resources for, and payment of, principal and interest on the College's long-term debt obligations.
- <u>Special Revenue Funds</u>- account for revenues and expenditures for specific projects legally and/or administratively restricted for a specific purpose.
 - Community and Workforce Development Fund \$1.06 million
 - Contract and Grant Fund \$31.7 million
 - Entrepreneurial Fund \$1.23 million
 - Intra-College Fund \$1.2 million
