Resolving Financial Aid Suspension

To reinstate access to financial aid after your eligibility has been suspended, you must do one of the following:

- Successfully complete at least one eligible term on your own (without financial aid). If your aid was suspended because you did not complete enough credits, you must complete the number of program credits you were short during the term suspension was earned. If it was due to a cGPA less than 2.0, you must bring your cGPA up to at least a 2.0 to be reinstated, or
- If you meet the following criteria, and you are able to provide supporting documentation for extenuating circumstances, you may submit a written **SAP appeal.** Forms are available online at www.roguecc. edu/FinancialAid/FA020.asp or from Rogue Central Services.

Extenuating circumstances are situations that:

- Are significant and documentable
- Are unforeseen and beyond your control
- Occurred during the term (after the drop period)
- Had a direct impact on your ability to successfully complete the term
- Meet one of the following cGPA Exceptions:
- O Student with a transcript of less than 13 graded credits who is enrolled in at least one developmental education course, passes at least 3 term-length credits and earns a cGPA less than 2.0
- Successfully complete ALL term credits but cGPA still less than 2.0

The Financial Aid Office will review your appeal and notify you of the decision in writing. If approved, you will be placed on probation status. If denied, the Financial Aid Office will remind you of how to reinstate your eligibility on your own. If you believe your appeal was misunderstood or denied in error and have additional clarification or documentation, you may re-appeal and a SAP committee will review. Committee decisions are final.

Satisfactory Academic Progress Policy



for Financial Aid Students Academic Year 2009/10

Effective Beginning Summer Term 2009



To maintain eligibility for federal and state financial aid, federal regulations require that you maintain satisfactory academic progress (SAP) toward the completion of your aid-eligible certificate or degree program. RCC measures SAP by cumulative GPA (cGPA), term credit completion and net attempted credits.

(To maintain eligibility for scholarships, you must meet the requirements set by your donor.)

Grades and Cumulative GPA (cGPA) Requirements

- You must maintain at least a 2.0 cGPA.
- Grades that impact cGPA are A, B, C, D and F.
- Satisfactory grades are A, B, C and P.
- Unsatisfactory grades are AU, D, F, I, NP, W, Y and Z.

Credit Completion

Each term, based on your award level, the Financial Aid Department verifies how many attempted credits you successfully complete. See status charts on reverse page for how it impacts your access to future aid.

- Attempted credits are courses you enroll in, do not drop/are not administratively dropped from, and that are listed on your academic transcript.
- Completed credits are A, B, C, D and P.

If your cumulative credit completion rate (completed credits, divided by attempted credits) drops below 68%, it means you may not be able to complete your program within maximum credit limit of 150% of program length. This may impact future appeals.

Maximum Credit Limit

You may have access to financial aid until you've earned at least a two-year degree or until it appears you cannot complete your program within 150% of program length (see program charts on reverse page). Otherwise, if you have changed your major, you may submit a Credit Extension Appeal form, available at www.roguecc.edu/FinancialAid/FA020.asp or at Rogue Central Services.

If a Credit Extension Appeal is approved, you must enroll only in required courses and you must successfully complete all attempted credits. Otherwise, your Credit Extension becomes void.

Financial aid is based on net attempted credits, not including up to 45 developmental education credits (see Aid Eligible Credits). When you submit an official

transcript, all earned credits are counted. After an official Degree Audit is done, only transferrable program credits are counted.

Determination of Award Level

Awards made prior to a term are based on planned enrollment. Adjustments are made through the end of the second week (drop period) or prior to payment, whichever is later. Eligible enrollment at the time of payment determines your award level. Once eligible payment is made, you are responsible to make SAP on that award level.

Aid-Eligible Credits

- Required program credits or approved electives for a declared certificate or degree program (up to maximum credit limit).
- Up to 45 developmental education credits, which include:
- O MTH20, 60, 63, 65, 93, 94, 95, 95R
- o RD20, 30
- O SK8
- O WR10, 20, 30

Non-Aid-Eligible Credits

- Adult Basic Education
- GED
- ESL
- Continuing education units
- Non-credit courses
- Repeated courses (unless program requires)
- Credit from challenge exams
- Audited courses
- Classes below 100 level that are not pre-requisites, required program credits or approved electives (i.e. CS60, HD50-99, SK31, etc.)

Repayment/Refund Policy

Financial Aid students who do not begin attendance will owe a complete repayment. Those who begin, but do not complete the term (drop out, withdraw, or stop attending) may not be eligible to keep their full funding and may owe a repayment. See Return to Title IV brochure.
