Applicants who have completed a non-nursing bachelor's degree in an English speaking country can use it to meet this requirement. <u>Footnote 4</u> = Electives may be required in pre-requisites and applied in order to reach the minimum 45 prerequisite credits. As needed electives may be required if students completed NFM225, PSY201 or PSY202, PSY215, WR121 and WR122, at 3 credits each, which are acceptable.
