## **Planning Ahead for the EMS Application**

Students planning for the EMT, AEMT, or Paramedic courses starting in the fall or winter can utilize the information below until the application and link to Qualified First is activated on April 1<sup>st</sup>. Entrance into the EMS course is granted to students who complete the process outlined in the application and below. We do not reserve positions in the course for students "in process" unless otherwise noted. For paramedic applicants, additional information will be required and is outlined in the application or can be provided by speaking to an EMS advisor.

On April 1<sup>st</sup>, this page will be updated to include the required information for purchasing the EMT or Paramedic application/tracker through Qualified First. Once that tracker has been purchased, you will upload all documents into that account; they **ARE NEVER** accepted in-person, by email, or by other means directly to our department. Qualified First is the only way documentation is accepted. If there are ever any concerns about why a document is not being accepted, contact Qualified First and then Rusty Riis at <u>rriis@roguecc.edu</u> if your issue still needs to be resolved.

## **Educational Requirements for EMT and AEMT**

(Paramedic applicants must meet with an Advisor for additional education requirements.)

All new RCC students must complete the placement process before registering for classes. This requirement may be completed based on college transcripts, placement test results from another college, qualifying or student self-placement process. - Students must have completed **RD90 or be eligible for RD115**
- Students must have competed WR90/WR91, or be eligible for WR115 or higher
- □ Students must be eligible for MTH20 or higher
- □ AEMT Only- Proof of EMT license is required to gain entrance into the course by the start of the course.

\*\*\* Students must provide proof of completion of the placement process or unofficial transcripts from RCC that meet the above requirements. Students who fail to provide appropriate documentation will be removed from the EMS registration process\*\*\*

## **Immunization and Required Forms**

Waivers of these course requirements based on religion, personal preference, or other reasons are not permitted due to public health safety standards that must be followed.

OFFICIAL medical documentation from a physician, clinic, county health department, or similar entity is required for each of the immunizations listed. School records are not accepted.

Requirement Name	Requirement Description
Measles, Mumps & Rubella (MMR)	<ul> <li>One of the following is required:</li> <li>2 vaccinations OR</li> <li>Positive antibody titer for all 3 components (lab report required).</li> </ul>
	Only <b>positive</b> titers are accepted.
Varicella (Chicken Pox)	One of the following is required: <ul> <li>2 vaccinations OR</li> <li>Positive antibody titer (lab report required) OR</li> <li>medically documented history of the disease.</li> </ul>
Hepatitis B	<ul> <li>One of the following is required:</li> <li>Two (Heplislav) or Three vaccination series OR</li> <li>positive antibody titer (lab report required).</li> <li>If series is in process, submit where you are in the series and new alerts will be created for you to complete the series.</li> </ul>
Tuberculosis (TB)	One of the following completed within the past 12 months is required: - 1 Negative skin test OR - IGRA blood test indicating a negative result ORÂ - if positive results, submit a clear chest x-ray.
Tdap except if TD is Less Than 2 years Old	Submit documentation of a Tdap booster within the past 10 years OR a Td booster within the past 2 years.
American heart Association BLS CPR Certification	Must be an <u>American Heart Association BLS Provider</u> card. NO OTHER CARDS ARE ACCEPTED. Online-only courses will NOT be accepted. Students must submit
	a card that includes an in-person skills component to fit the requirement.
Criminal Conviction Form	This form will be available for download. You must download and report all arrests, convictions, and any prior medical license revocations or suspensions. If there is a question about your background contact Rusty Riis at <u>rriis@roguecc.edu</u> .
Course Registration Form	This document will be available for download. You must download and complete all portions. If you are a student transferring in, you will need to have official transcripts on file or proof of meeting the entrance requirements with a placement test or prior RCC courses taken.
