### Agenda Item(s):

#### 1. Budget projections as of 2/13/20

Lisa reviewed the General Fund Projections spreadsheet.

- a. The majority of RCC's expenses are related to personnel costs as the College is a service based institution.
- b. RCC has three main funding sources:
  - Property taxes
  - State operations - paid through the State's funding formula
  - Tuition
- c. The only federal funding community colleges receive is through grants.
- d. Faculty and staff salaries are discussed at FAMAT and CAMAT (management/association) meetings.
- e. It has been announced the SOHOPE grant may have one more year continuance.
- f. Budget projections are assumptions based on our best knowledge right now. Changes will be made as we work through the budget process.
- g. Administration has made a recommendation to the Board of Education for a \$4.00 tuition increase with no increase to fees. The Board will make a final decision at their March meeting. The reason this decision needs to be made in March relates to the timing of putting together financial aid packets for students.

#### 2. Meeting w/Student Government

Lisa will be meeting with the Associated Student Government of RCC (ASGRCC) on 2/28 and per request, will provide a breakdown of personnel costs.

#### 3. Questions/Answers

A. **Q:** Do colleges receive lottery funding?

**A:** Lottery funds reach community colleges through:

- Capital dollars such as (examples) purchasing a building or building a new facility
- State funding formula



- B. **Q:** Has enrollment been continuously declining over a period of time?  
**A:** Lisa displayed the enrollment chart and explained that, historically, a decline in enrollment occurs when unemployment is low. When unemployment rises, more people attend college.

#### 4. **General Budget Information**

- A. Oregon budget law requires that RCC provides a balanced budget.
