

ROGUE COMMUNITY COLLEGE ZIPLINE FIELD TRIP GUIDELINES & WAIVER

- In addition to this packet, all ZipLining participants must sign an RCC General Purpose Waiver and a
 Medical Information & Emergency Contact Form in order to participate in the Ziplining Trip.
- All participants should be in good physical condition and be comfortable with extreme heights and the
 activity of ziplining. Persons with any disabilities, medical restrictions, or any limitations-including limitations
 set by the vendor, which would prohibit them from participating in this physical activity should not attend.
- Group leaders are responsible for providing all persons in their group with trip information. All participants should be prepared for all weather conditions.
- Any specific clothing or footwear required by the vendor must be worn by all participants while on the premises.
- All safety equipment issued by guide for the trip will be worn by all participants at all times.
- RCC reserves the right to have the final say in all matters pertaining to the trips and to amend policies at any time.
- Participant is responsible for the return of any and all equipment for the event which is provided or supplied by vendor, and agrees that any such equipment will be returned in the same condition it was in when it was delivered to participant.
- Although RCC takes every precaution to make field trips safe and enjoyable, there are elements of danger
 in this event; thus you must travel at your own risk.

ROGUE COMMUNITY COLLEGE ACTIVITIES, HAZARDS AND RISKS SPECIFIC TO RCC ZIPLINING TRIP

Participation by participant in the RCC ZipLining Trip may include but is not limited to the following activities, scheduled and unscheduled, voluntarily and involuntary: travel by foot and zipline, hiking, climbing on rocks and slopes, and travel to and from the activities.

The hazards and risks (together referred to as "risks") of the use of the zipline include but are not limited to the following: physical maneuvering such as bending, twisting, lifting, climbing and swinging; entering, exiting and operating the harness; zipline cable-on which you will descend an elevated wire at high speeds and swings; objects which may be encountered on and off the zipline, and which may not be obvious, including debris, trees, rocks, boulders, wildlife, reptiles, poison oak, insects and other hazards including; increased heart rate and breathing rate, equipment malfunction and/or human error.

Participant acknowledges and understands that the description of the activities and risks above is not complete and that all activities, whether or not described, may be dangerous and may include risks which are inherent and cannot be reasonably avoided without changing the nature of the activity. Participation in the activities can cause bites, stings, allergic reactions, overexertion, heat stroke, hypothermia, burns, cuts, bruises, strains, broken bones, and other injuries and illness. Property loss, and serious injury and death, including by falling and tumbling, are possible.

RCC has made no effort to determine, and accepts no responsibility for, medical, physical or other qualifications or the suitability of participant, or other participants, for the activities. Participant accepts full responsibility for determining participants medical, physical or other qualifications or suitability for participating in the activities. Certain activities may be conducted by independent contractors hired by RCC. These contractors are not trained or supervised by RCC and RCC has no control over them and accepts no responsibility for their conduct. Participant should inspect terrain and other hazards before attempting to pass through or over them.

I, the participant, understand the nature of the activities which may occur in connection with RCC's ZipLine Trip, and the risks thereof, and acknowledge and agree that execution by participant of the RCC General Purpose Waiver, to which this document is attached as an addendum, includes but is not limited to a full release and waiver of any injuries and/or damages arising from such risks, whether or not described above, known or unknown, and inherent or otherwise.
