4. Project Description *

This project will provide for critical renovations to the Marjorie Holzgang Concert Bowl at the Rogue Community College Redwood Campus. Constructed in 1982, the Bowl was a key piece of the community art and music scene that has fallen into disuse because of lack of handicap accessibility, lack of emergency access, and missing or outdated lighting and sound equipment. The total cost of the required work is approximately \$2,500,000. The budget includes final project design, construction drawings, permit review, construction management, and construction. While preliminary scoping and conceptual design work has already occurred, the College will also seek additional input and technical assistance from local theater and musical groups to ensure that the final design meets the needs and expectations of the community. This project qualifies for funding as an Economic Development Initiative eligible under Chapter 69, Title 42, United States Code(42 USC 5305). The renovation of the Bowl as a community facility is considered to be an eligible activity, and improving access to the venue for individuals with disabilities is objectively within the public interest. The project has broad community support; the true performance standard will be demonstrated through a community rededication ceremony that includes performances by local musical and theatre groups.

The primary activity this project will address is the removal of architectural barriers that limit access to the Bowl by individuals with limited mobility, including the elderly and handicapped persons. All individuals that are elderly or have a handicap that requires the removal of architectural barriers, including the installation of ADA-accessible walkways, railings, seating areas, and restroom facilities, are considered to be of low- or moderate-income. Furthermore, the project is located within Josephine County, which has an overall LMI rate of 46.16%.
