Champions Update on Strategic Plan Progress	<p>May 9 deadline extended to May 15, 2012 (see attached memorandum for distribution to department chairs). Cheryl M. has already engaged faculty in extensive program evaluation process. She will work with them to cut and paste their responses in that process to the SP assessment document.</p> <p>BACON meeting scheduled June 19, 9 a.m. – 1 p.m. (location TBD) in Medford. Once location is confirmed Mary O. will send invitation to E-Team, CEC and Strategic Plan Champions.</p> <p>Will determine if 2011-12 Strategic Plan and 2011-12 Core Themes should be assessed together or separately as integrated strategic planning model develops. Core theme champions will complete template (dated 4/16/12) based on work initiated to date and produce to synthesis team by May 18.</p> <p>Still some confusion about terminology; champions’ assignments clarified to include incorporation of core theme work to date into new template.</p>

5. SENSE Update (Curt)	Timeline and process were provided via email. Kori asked that Gateway courses be identified for oversamples and follow-through on high-touch/high density learning strategies introduced by On Course at upcoming spring inservice. College services will pay the additional fee for the oversampling. Gateway courses may be, for example: three entry-level math courses, WR 115 and 121, yet to be determined. Curtis will be requesting assistance from Chelsea Kelsey for survey distribution during fall term 2012 . Key findings will be available on or about March 1, 2013 .
