On April 21, 2008, Dr. William Bonaudi, President, Big Bend Community College, an evaluator for the Northwest Commission on Colleges and Universities (NWCCU) will be on site to review RCC's progress on Recommendations 1 (strategic planning), 2 (assessment) and 3 (faculty evaluations), resulting from the College's Fall 2006 Interim Report and visit. In Fall 2008, RCC will prepare a Progress Report in response to Recommendations 4 (governance), 5 (financial plans) and 6 (master facilities plans) from the same Fall 2006 Interim Report.

COMMUNITY COLLEGE SURVEY OF STUDENT ENGAGEMENT (CCSSE)

This new survey puts RCC in synchronization with the other Oregon community colleges. Conducted biennially in even years, the CCSSE provides a muchneeded tool for assessing quality in community college education. The survey asks questions about institutional practices and student behaviors that are correlated with student learning and retention. The results are public and include national and institutional benchmark scores for key areas of engagement. CCSSE does not use the data to rank colleges but to provide a tool for

Improving educational practice and performance.

Twenty-five volunteers are surveying 37 classes from various programs and times on all three campuses (16-RWC, 17-RVC, 4-TRC). Three are evening classes. Surveys are being conducted now through March 14 this term. Results will be in by July 31 for the next round of planning.
